

BEFORE REQUESTING PERSONAL DATA

Are you certain that you need to request non-public contact details of a domain name holder for legal purposes?

This request form is intended **exclusively for specific lawful and legitimate purposes**. Please verify whether your situation genuinely requires access to personal data before submitting a request.

Use this form **ONLY** if:

- You have a **legal basis** to obtain non-public domain name holder data
- You are involved in a **legal dispute**
- You require the data for the **enforcement of intellectual property rights**
- You are acting on behalf of a **government or law enforcement authority**
- You can submit a **sufficiently substantiated request**, including supporting documentation

Incomplete, irrelevant, or insufficiently substantiated requests will be rejected.

Your request will be evaluated based on **legitimate interest** and **completeness**.

If the request is approved, the requested data will be provided within **72 hours** (or within **24 hours in cases of urgency**). If urgent, then this should be instantly clear from both the subject and body of the e-mail in which this form is sent and this needs to be justified further below in this form..
